October 2, 2018
MINUTES

1. CALL TO ORDER

Chairman Raymond called the meeting to order.

2. DETERMINATION OF QUORUM

3. APPROVAL OF MINUTES

A. Approve Minutes

4. PRESENTATIONS

A. UPWP Studies Update

Staff provided an update on three current UPWP projects – Mobility East, 115 North and 115 South. The Board commented that they were anxious to get more details about the work being done on the Mobility East study.

6. OLD BUSINESS

A. “Why Can’t They” List and Discuss Public Input

The Board discussed the current list of potential projects on this list and asked staff to provide a complete list for the next meeting. Staff was asked to see how TAB could use the Cornelius website to spread the word and follow up next meeting.

7. NEW BUSINESS

A. REZ 06-17 Catawba at Knox

Aaron Tucker presented information about the proposed rezoning and development and opened it up for discussion. The Board commented that the intersection at Knox Road/Harken Drive may be problematic. There was also concern about the removal of split phasing at One Norman/West Catawba Avenue intersection.

B. REZ 01-18 CD Nantz

Aaron Tucker presented information about the proposed rezoning and development and opened it up for discussion. The Board had no comments on the project. The Board discussed timing of when projects are brought to TAB. TAB would like to review a project after the Pre-Development Review Committee meeting once application is filed. The Board also directed staff to add proposed uses for potential projects in the DIP spreadsheet and include in a simplified presentation.

C. Knox Road/Holiday Lane Connection

The Board discussed that an east/west connection across I-77 from Knox Road to Holiday Lane could help take the strain off of the Catawba Avenue/US 21 intersection.
