- This work was completed in October of 2016




Executive Summary


- Cornelius has an abundance of Historic properties
 - "Historic" is generally defined as 50 years old or older
- "The sum is greater than the parts"
 - Focus on areas that have many historic resources in close proximity
 - Preserve the historic fabric of an area rather than just single structures
- The goal of the evaluation
 - Highlight areas with significant historic resources by combining knowledge from the Charlotte Mecklenburg Historic Landmarks Commission and the Town of Cornelius HPC



Property Identification

- All structure 50 years and older
 - ~200 properties
- The HPC narrowed down the list to 50 properties to focus on for detailed evaluation
 - Qualitative Evaluation to get down to 50 properties






Historic Areas

- Why Historic Areas?
 - CMHLC identified these areas during their 2013 survey??????
- What are Historic Areas
 - Not Districts, just rough boundaries consisting of cohesive properties within the historic inventory
 - Historic Areas are fluid and should be grouped together or amended as appropriate

Historic Areas

- Gem Yarn/Oak Street
- Catawba
- Old Statesville Rd
- Zion
- North Main
- Central Residential
- Mill Village North
- Davidson Street
- Cornelius Street

Evaluation Criteria

- Ranked each property 1-5 in the following three criteria
- Community/Historical Significance
 - Cultural relevance to the founding, development and history of Cornelius
- Endangered
 - Perceived or immediate threat of demolition
 - Future impact of redevelopment
- Architectural Integrity/Significance
 - Unique architectural features
 - Well preserved or rehabilitated property
 - We're not Architects...

Architectural Integrity/Significance

- Show chart of 10 top scoring Architectural Properties
 - Highlight the properties that will show up in all of the 10 top lists

Endangered

- Show chart of 10 top scoring Architectural Properties
 - Highlight the properties that will show up in all of the 10 top lists

Community/Historical Significance

- Show chart of 10 top scoring Architectural Properties
 - Highlight the properties that will show up in all of the 10 top lists

Overall top scoring properties

- Show a chart of the top 10 overall scoring properties
 - Include pictures of these properties in the background

Overall top scoring properties

• Show a map that only highlights the top 10 scoring properties to give some geographic context. Keep it simple, not busy.

Historic Areas

- Show a table that ranks the historic areas by their average scores
 - Advance with an animation to switch the table to a map which shows the areas again

Priority Areas and Properties

- Mention the historic areas that have great integrity and unique character
 - Catawba area with lots of contributing properties, also includes the commercial buildings, Cherry House/Washam office
 - Catawba, Gem Yarn/Oak st, and Mill Village South combine for triumvirate of mill town pieces (residential, mill town stores, and cotton gin)
 - Maybe mention Cornelius St area, unique story, last mill homes built in the area.

There was also mention of additional maps to show the proposed Arts District overlay and where high priority properties/historic areas overlap.
