Introduction to CACC Executive Director

Chair Miller and the committee gave a brief overview of the historic resources in Old Town Cornelius.

Justin Dionne, the Executive Director of the Cornelius Arts and Community Center gave brief overview of his experience in Salisbury and an introduction to the planning process for the design of the Arts Center. Mr. Dionne explained each phase of the planning process.

Chair Miller invited Mr. Dionne to the "Tawba Walk" for a walking tour on September 16, 2017.

Mr. Dionne will be present at the "Twaba Walk" to educate the community about the Art Center.

The committee explained the significance of the Cotton Gin to Mr. Dionne and why it is important to preserve the scales. They also stated that their main objective is to preserve as much as possible but they do recognize that sometimes compromises have to be made.

Mr. Dionne informed the Committee that the Art Center is still in the listening phase and informed them to get more involved by going to the input sessions.

Charlotte Mecklenburg Historic Landmarks Commission Update

Two properties in Cornelius were added to the Survey Committee's "Study List". The study list is basically the Survey Committee's "good pile" of properties to consider recommending to the Landmarks commission for designation.

19721 South Ferry Street- Owners, Carrie Nelson and James E. Caldwell

- CMHLC Staff believes this is a great candidate for designation with ample historical significance.
- Staff would recommend that the CMHLC Pay for the survey and research report required for property designation.
- The only piece holding this property back righ now if input from the current property owner
- CHMLC staff recommends that if the Cornelius HPC is interested in moving forward (and submits a request to CMHLC staff) then this property could potentially be put on the Survey committee's agenda on September 4th to recommend the property to the Landmarks Commission to consider for designation.

19528 Meridian Street- Owners, Julie Miller, Joseph Miller

- CMHLC staff believes more research is needed on this property
- Basically a mini survey and research report that would help provide context to the entire neighborhood and how this property fits into that context relative to the other structures.

Tawba Walk Walking Tour

The committee brifly discussed the Twaba Walk. Each member will sign up for a time at the booth. The committee will continue the planning by email.

Trash or Treasure Planning

Facts Concerning Historic Landmarks Status

- The Charlotte-Mecklenburg Historic Landmarks Commission exists to recommend the designation of individually significant historic property. It derives its powers from North Carolina General Statute 160A-400.
- The essential test of whether property qualifies for historic landmark designation is whether it possesses individual historic significance. There is no specific age requirement.
- Owners of historic landmarks may apply for an automatic deferral of 50% of the local property (Ad Valorem) taxes on those portions of the property which have been designated as a historic landmark.
- Owners of a historic landmark must obtain a Certificate of Appropriateness from the Historic Landmarks Commission before undertaking any material alterations to those portions of their property which have been designated as a historic landmark.
- The demolition of a historic landmark may be delayed for up to 365 days by the Historic Landmarks Commission and during this period the appropriate local governing board may exercise the power of eminent domain to acquire the subject historic landmark.
- The Charlotte-Mecklenburg Historic Landmarks Commission uses two principal tools to advance the preservation of designated historic landmarks. First, it exercises design review over intended material alterations to historic landmarks. Second, it acquires historic landmarks with the purpose of preserving the property.
